FACT SHEET: United States Response to the Clade I Mpox Outbreak in Several African Countries

The World Health Organization (WHO) declared a Public Health Emergency of International Concern about the upsurge of mpox cases in the Democratic Republic of the Congo (DRC) and a growing number of countries in Africa. This announcement followed the Africa Centres for Disease Control and Prevention's (Africa CDC) declaration of a Public Health Emergency of Continental Security on August 13.

The significant increase of clade I mpox cases, in both endemic countries (those that have previously had mpox outbreaks) and non-endemic countries (those that have historically not reported mpox outbreaks), threatens the health security of the region, as well as countries outside Africa. In addition, clade I mpox has a newer sub-clade referred to as clade Ib. Both clade Ia and clade Ib are circulating in DRC and have been detected in neighboring countries and

in Sweden and Thailand (one case each associated with travel to Africa with known clade I cases).

In 2022, the world experienced a global outbreak of clade IIb mpox, which led to more than 95,000 cases across 115 non-endemic countries and continues to occur in the United States. The Biden-Harris Administration responded by ensuring the JYNNEOS see CDC pg. 5

Stadium and Baseball field. The vandals struck the rock at the front of the school stadium entrance and continued vandalizing trash cans, signs, and whatever could be

Painted including the baseball stands and the two new signs outside the baseball stadium acknowledging the Panthers Victories. Then to the football stadium where the vandals damaged beyond repair a \$5000 Camera in an attempt to hide their identity. Then they vandalized the press box area. Fortunately no damage was done to the field or the new training facility at the stadium.

Chief Don White, LCPD reported six juveniles have been found and have admitted to the vandalism. Chief White also stated charges will be coming. The value of the damage was well over

Chief White further noted he will be letting the public know more information as it becomes available. White also added none of the vandals were on or associated with the football program from either school but were high school students.

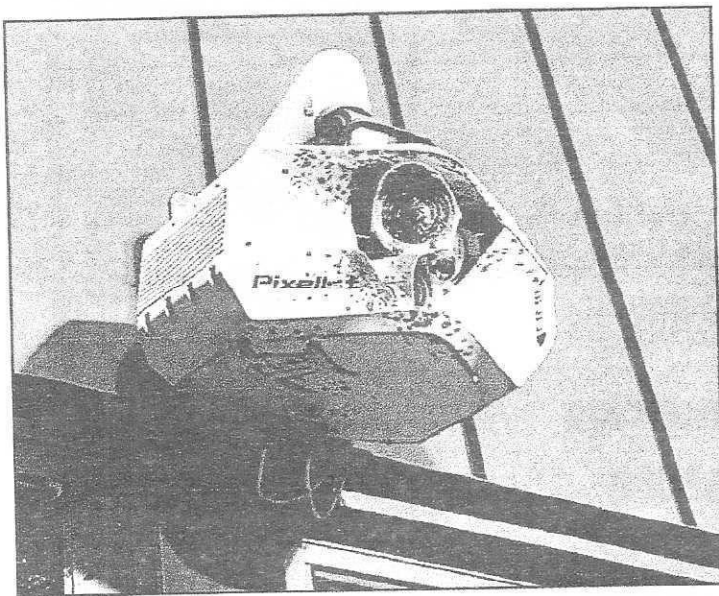
The game began and after a long fought battle saw the Panthers lose in the final seconds after a field goal was blocked clinching the win for the Redskins 7-6.

Deputy Kirkland along with Deputy Miller LCSO,

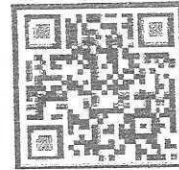

Officer Hardwick stated he observed the vehicle failing to maintain its lane of travel. Deputies arrived on the scene to assist the TWRA officer. The driver, Michael Greene, admitted to drinking a couple of beers a few hours prior. Officer Hardwick stated that he suspected the driver of being intoxicated and due to suspected DUIs being out of his daily tasks, we offered to take over the stop. Deputy conducted SFSTs on Michael and he performed poorly. Deputy could smell the odor of an alcoholic beverage coming from his breath and he was unsteady on his feet. Michael was read implied consent, and he stated he had no comment. The deputy told Michael it was a yes or no answer and he stated he would rather not make a comment without his lawyer. Michael failed to provide a sample of his blood for chemical testing, he also refused to sign the implied consent paperwork. This did occur in Loudon County, Tennessee.

DUI

Jacob Dance, 30, Lovell View Drive Knoxville, was charged with DUI, Violation of Implied Consent, and Driving on Roadway Laned for Traffic.

Deputy Willis LCSO, was at the traffic light at the intersection of Highway 321 and Highway 70 when the deputy observed a blue Honda CRV with no working brake lights. Once the light turned green, the deputy got behind the vehicle. While behind the vehicle the dep-

uty observed it crossing the Fog Line multiple times. The deputy initiated a traffic stop at the intersection of Highway 321 and Waller Ferry Road. Upon making contact with the Driver/Offender Jacob Dance, Mr. Dance could not provide him with a driver's license. Mr. Dance showed multiple signs of impairment and nervousness. The deputy asked Mr. Dance to exit the vehicle and step to the front of his vehicle. While walking to his vehicle Mr. Dance had

a unsteady gait. Mr. Dance asked if he could lean on his front bumper. Mr. Dance did agree to do Standardized Field Sobriety. During the Horizontal Gaze Nystagmus test the deputy observed Mr. Dance to have lack of smooth pursuit in both eyes as well as distinct and sustained nystagmus in both.

Once the deputy began instructions on the walk and turn test Mr. Dance began stated he could not do the test. Mr. Dance refused to

complete the rest of the tests. Mr. Dance was placed into custody for Driving Under the Influence. Mr. Dance was read the Tennessee Implied Consent Form and he refused to provide a sample. Mr. Dance was also charged with Implied Consent and Driving on Roadways Laned for Traffic. During the traffic stop he was also written a warning for Lights Required on a Motor Vehicle.

This did occur in Loudon County Tennessee.

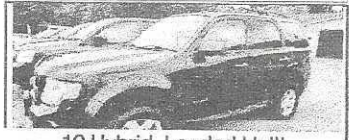

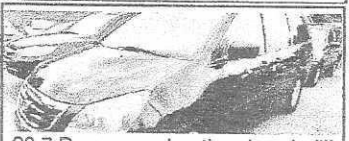

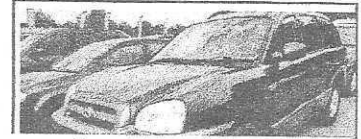

mpox vaccine was available to at-risk populations in the U.S.

In February, as the clade I mpox outbreak grew in DRC, the Biden-Harris Administration established an incident response structure across federal departments and agencies to ensure a coordinated response and to take a proactive approach to U.S. domestic preparedness for potential clade I mpox cases. Clade I mpox causes a higher number of severe infections and has a higher mortality rate than clade IIb mpox. Because evidence for clade I mpox clinical outcomes is based primarily on data from endemic countries without widespread supportive care, particularly DRC, we do not yet know how clade I mpox would im-

act Americans; we do expect it would cause lower morbidity and mortality in the United States.

United States preparedness for clade I mpox

The Biden-Harris Administration has been closely monitoring the spread of mpox, specifically clade I mpox, and has been working since December 2023 to prepare domestically. The risk to most Americans from clade I mpox circulating in Central and Eastern Africa and the travel associated cases outside of Africa is very low, and there are no known cases in the United States at this time. The United States is well prepared to rapidly detect, contain, and manage clade I cases should they occur domestically.

The United States continues

to increase our capacity to detect cases of clade I and clade IIb mpox through existing surveillance systems, including wastewater testing, and through expanding the robust diagnostic testing capacity built during the ongoing clade IIb outbreak to ensure coverage for clade I. The ability to expedite such diagnostic testing—in particular for those with recent travel to DRC or neighboring countries—also supports rapid detection. In addition to reaffirming the importance of mpox vaccination for those who are eligible, we are working to prevent the spread of both clades of mpox by providing and disseminating recommendations for clinicians, health departments, diagnostic laboratories, and the public.

From August 2022 to August 2024, the Administration for Strategic Preparedness and Response (ASPR), part of the Department of Health and Human Services (HHS), distributed more than one million vials of the JYNNEOS vaccine across the United States to mitigate the spread and severity of the clade

II mpox outbreak. In addition to the preventive vaccine, partners across the U.S. government are working to better understand the effectiveness of existing treatments for mpox and have treatment options available in the event that clade I mpox is reported in the United States. The United States will continue to provide information to the public on transmission, prevention, and treatment of mpox. Those who have already had clade IIb mpox or who are fully vaccinated against it are expected to be protected against clade I mpox.

CDC has issued an updated Health Alert Network advisory for clinicians and public health departments and partners, as well as an updated Travel Health Notice, recommending travelers to DRC and neighboring countries to practice enhanced precautions. Through the State Department, our embassies are working to keep U.S. citizens abroad informed of these updates. At this time, CDC and WHO do not discourage travel to DRC or elsewhere due to the mpox outbreaks.
