## Former Tarpley Shop Utility District General Manager Indicted for Theft

*Utility was located in Pulaski, Tennessee*

An investigation by the Tennessee Comptroller's Office has resulted in the indictment of Freddie Byrd, the former general manager of the Tarpley Shop Utility District (TSUD) in Pulaski. TSUD provided water service to approximately 1,200 customers prior to its merger with South Giles Utility District earlier this year.

Investigators determined that Byrd made personal purchases with district funds totaling \$7,939.55 between 2017 and 2023. The majority of these purchases included battery-operated tools; small equipment and repairs; and vehicle parts that did not fit district-owned vehicles.

Byrd made other questionable purchases with district funds totaling \$9,849.64 from

a variety of vendors. Investigators were unable to confirm if the all the purchases were used exclusively for official district purposes.

The investigation also revealed that \$25,035.79 in questionable fuel purchases were made with TSUD funds. Due to a lack of documenta-

### Sexual Battery

Michael Richardson, 35, Simmons Road Loudon, was charged with, Sexual Battery, and Attempted Rape.

Cpl. B. Dishner LCSO, responded to the Loudon County Sheriffs Office to meet with a subject advising she had been sexually assaulted. Upon arriving on scene Cpl. Dishner made contact with the victim. She stated that her and the offender Michael Richardson had been broken up for about a month, but her dogs were still being kept at his address. She stated she had went to his residence at approximately 0515 hrs. to

feed, and care for her dogs. Once she arrived on scene Mr. Richardson also came outside to check the brakes on her vehicle. When he approached the car he attempted kissing the victim when she pulled away, and told him no.

She then went to the exterior utility building where the dogs were housed. Mr. Richardson followed her, and once at the door he began to fondle her. She stated he slid his hands under her shirt, and grabbed her breasts. Again she pulled away from him, and told him not to touch her. She entered the building then start caring for the dogs at

which time Mr. Richardson entered the building attempting to corner the victim, and continuing to try and fondle her. She was able to get away from him at which time she exited the building, and went to her vehicle. She stated once at her vehicle she was standing at the rear passenger door when Mr. Richardson came up behind her. He then pressed himself against her, and unbuttoned her pants. He then pulled her

pants down, and she advised his pants were also down because she could feel himself against her. During this time she told him to stop multiple times, and it wasn't until she was able to kick him that he stopped forcing himself upon her. Cpl. Dishner advised Inv. Sgt. Marty Branam of the situation at which time he responded to the Sheriffs Office to speak with the victim. This did occur in Loudon County Tennessee.

tion, investigators were not able to determine if all the fuel purchases were used exclusively for district purposes.

Based upon this investigation, on July 10, 2024, the Giles County Grand Jury indicted Freddie Byrd on one count of theft over \$2,500 but less than \$10,000, and two counts of official misconduct.

“Our investigators found a number of weaknesses and deficiencies within the financial operations of the TSUD,” said Comptroller Mumpower. “Although, this utility has merged with another, it’s important for all utilities to have strong policies, internal controls, and board oversight to ensure operations are conducted properly and responsibly.”

**Two Knoxville Men Convicted of Methamphetamine Conspiracy and Distribution**

Following a five-day jury trial in United States District Court in the Eastern District of Tennessee at Knoxville,

a jury convicted Cumecus Cates, 48, and Grady Chandler, 43, both of Knoxville, Tennessee, of Conspiracy to Distribute over 50 grams of Methamphetamine, in violation of 21 U.S.C. §§ 846 and 841(1)(A) and multiple counts of Distribution of over 50 grams of Methamphetamine, in violation of 21 U.S.C. §§ 841(a)(1), 841(b)(1)(A) and 18 U.S.C. § 2.

The sentencing date for Cates and Chandler will be set later this year before the Honorable Katherine A. Crytzer, United States District Judge, in the United States District Court at Knoxville. Cates and Chandler both face sentences of up to life in prison.

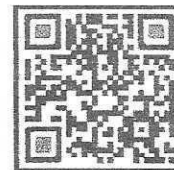
The evidence presented at trial included FBI recorded drug transactions, witness testimony, and seized narcotics, and showed that Cates and Chandler were distributing large quantities of methamphetamine in the Knoxville area throughout 2022 and 2023.

United States Attorney Francis M. Hamilton, III of the Eastern District of Tennessee made the announcement.

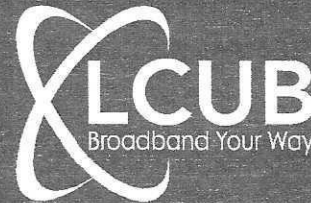

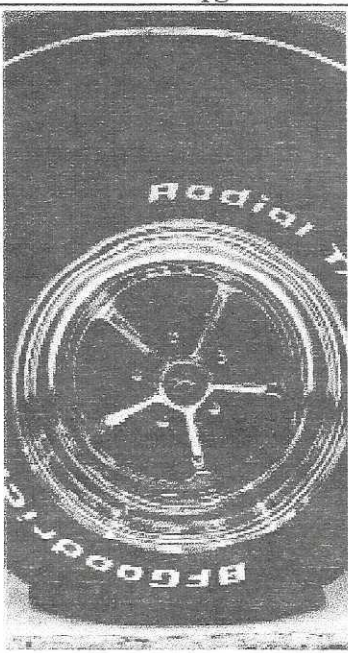

John Foti, 18, Stahl Drive Knoxville, was charged with, Underage DUI, and Underage Consumption.

Andrew Garza, 18, Longbow Road Farragut, was charged with Public Intoxication, and Underage Consumption.

Deputy Watson LCSO, did observe a vehicle traveling 69 in a 50 mph zone. Deputy Watson stopped the vehicle for speeding and made contact with John Foti (Offender/Arrestee) in the driver's seat. While speaking with Mr. Foti, the deputy detected a strong odor of an intoxicant emitting from inside the vehicle. Mr. Foti admitted to having approximately 2 drinks prior to driving his vehicle. After gathering Mr. Foti's driver's license, the deputy determined that he was under the age of 21. Deputy Watson asked Mr.

Foti to exit the vehicle and step to the front of his patrol vehicle. While speaking with Mr. Foti outside his vehicle, Deputy Watson observed Mr. Foti to have bloodshot watery eyes, dilated pupils, and a strong odor of intoxicant emitting from his breath. Mr. Foti agreed to perform SFSTs/ARIDE testing and was unable to finish testing due to stating he felt like he was going to black out. Mr. Foti was then placed into custody for suspicion of driving under the influence and secured in his patrol vehicle. The passenger of the vehicle was identified as Andrew Garza (Offender/Arrestee) who was also found to be under 21. When speaking to Mr. Garza, he did admit to drinking approximately 4 beers. Deputy Billy Freeman then pulled Mr. Garza out of the vehicle. While speaking to Mr. Garza out of the vehicle, he

was found to have bloodshot eyes and a strong odor of an intoxicant on his person. Mr. Garza was then placed under arrest for public intoxication and underage consumption. Mr. Foti was read implied consent and consented to a blood draw. Mr. Foti was transported to Fort Loudon Medical Center. 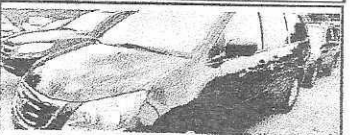

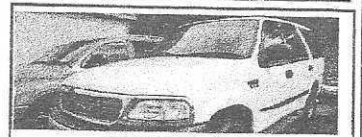

Chelsey Coker, 28, Sunnyside Road Philadelphia, was charged with, Aggravated Assault, Possession of a Weapon while Under the Influence, Public Intoxication, Convicted Felon in Possession of a Handgun.

Deputy Phegley LCSO, was dispatched to Old Sugarlimb Rd in reference to a female with a weapon.

Upon arrival deputies made contact with Chelsea Coker, and victim 1 on the front porch. Victim 2 was also on scene, inside the residence when deputies arrived.

Ms. Coker, and victim 1 both yelled as officers approached that the gun was unloaded and out of their possession. Ms. Coker was detained for officer safety. Ms. Coker was read her rights and made multiple statements after. Ms. Coker did not make much sense in her statements and would not give information as to where she obtained the firearm, but did state she bought it from someone. Ms. Coker seemed to be under the influence of a narcotic, her behavior was very erratic, and fidgety.

Victim 2 stated she was inside the residence and no-

Victim 1 stated Ms. Coker arrived to the residence in a chevy truck. Ms. Coker then came up on the porch and

pulled the firearm from her bra, and put victim 1 in fear. Victim 1 also advised Ms. Coker was high on meth.

Per Ms. Coker's criminal history she is a felon. Deputy charged Ms. Coker with aggravated assault, felon in possession of a firearm, possession of a firearm while under the influence, and public intoxication.

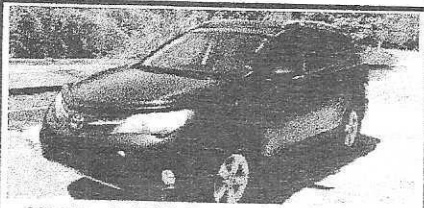

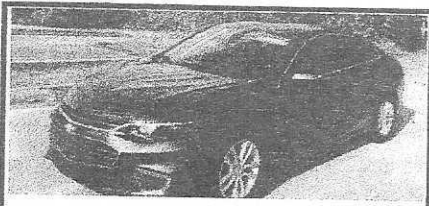

Law enforcement agencies participating in the joint investigation which led to indictment and subsequent conviction of Cates and Chandler included the Federal Bureau of Investigation (FBI) HIDTA Task Force. The FBI HIDTA Task Force includes the Roane County Sheriff's Office, Knoxville Police Department, Knox County Sheriff's Office, Blount County Sheriff's Office, and Sevier County Sheriff's Office. The Drug Enforcement Administration also assisted in this investigation by conducting drug analysis on seized narcotics in the case.

Assistant U.S. Attorneys Cynthia Davidson and Michael Gilmore represented the United States at trial.

This case was part of the Department's Organized Crime Drug Enforcement Task Force (OCDETF) and the HIDTA programs. OCDETF is the primary weapon of the United States against the highest-level drug trafficking organizations operating within the United States, importing drugs into the United States, or laundering the proceeds of drug trafficking. The HIDTA program enhances and coordinates drug control efforts among local, State, and Federal law enforcement agencies. The program provides agencies with coordination, equipment, technology, and additional resources to combat drug trafficking and its harmful consequences in critical regions of the United States.

Cpl. J. Sartin LCSO, observed a maroon Mazda traveling on Loudon Ridge that was crossing over the center

The California ID number was checked through dispatch and was found to belong to female out of Bakersfield, CA. Mr. Gracia Perez was taken into custody and charged with Identity Theft and License required. This did occur in Loudon County, TN.

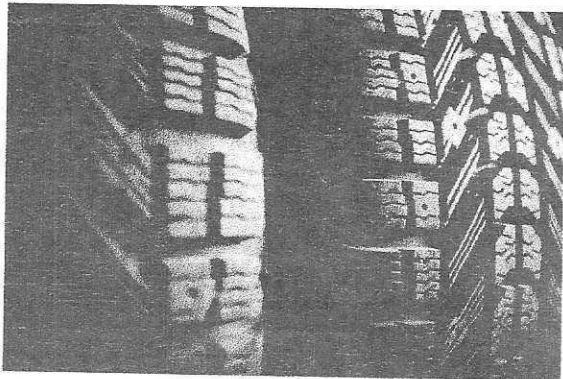
