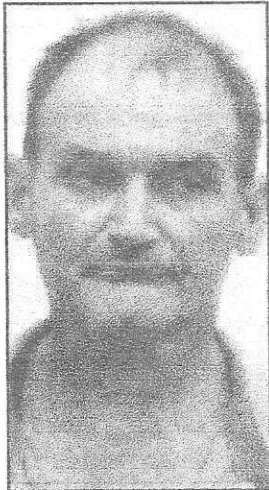

Executive Director of Energy Efficient Schools Initiative Faces Theft Charge

An investigation by the Tennessee Comptroller's Office has resulted in a criminal information being filed against Paul Cross for one count of theft over \$10,000. Cross is the executive director of the Energy Efficient Schools Initiative (EESI) in Tennessee.

The EESI was established in 2008 with a one-time allotment of \$90 mil-

lion derived from excess lottery funds. Its purpose is to provide Tennessee's public K-12 schools access to low-interest revolving loans that fund energy-efficient projects. The EESI is directed by a 12-member council and is attached to the Tennessee Department of Education.

Investigators determined that Cross misappropriated at least \$11,130 by failing to

report leave when he was not working between 2021 and 2023. Cross claimed to be working at least 210 hours of time when he was absent from work. Investigators calculated Cross was paid approximately \$53 per hour for this time.

Cross admitted to investigators that he did not work the hours

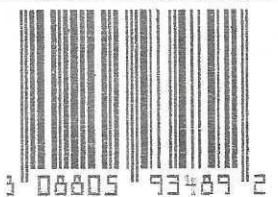

Mary Arden, 54, E Street Lenoir City, was charged with, Mfg/Del/Sale or Poss. of Meth, Mfg/Sell/Del/Re-sale Sch. II & I, Maintaining a Dwelling where Drugs Sold, and Poss. of Drug Para.

Ted Hamilton, 46, Beals Chapel Road Lenoir City, was charged with, Mfg/Del/Sale or Poss. of Meth, and Poss. of Drug Para.

Kimberly Morgan, 59, E Street Lenoir City, was charged with, Mfg/Del/Sale or Poss. of Meth, and Poss. of Drug Para.

The Loudon County Sheriffs Office Narcotics Unit executed a search warrant at N. E St. Lenoir City, TN, in search of controlled substances. The Loudon County Sheriffs Office Swat team secured the residence and made contact with Mary Arden, a male, Robert Rushing, Ted Hamilton, Kimberly

Morgan, and David Morgan and detained them. Upon search of the residence, units recovered 13.6 grams of Methamphetamine, .54g of suspected black tar heroin, 1.11g of powder Fentanyl, .78g of suspected blue powder fentanyl, 79 round gray pills with a box M imprint on one side and "20" on the opposite side. These pills are believed to be pressed fentanyl pills, intended to imitate 20mg Oxycodone.

In addition to the controlled substances, units also recovered hundreds of empty bags, digital scales, and \$975 in US Currency, in various denominations, believed to be the proceeds of drug sales. Investigators also recovered 1.21g of Methamphetamine from the main living space (Room A), along with various types of drug paraphernalia. All subjects, excluding one male, were taken into

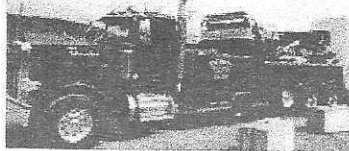

custody. Upon arrest David Morgan was found to be in possession of 1.27g of Methamphetamine, concealed in a purple cylinder container in his pants pocket. Robert Rushing had an active warrant for violation of probation out of Monroe County. All subjects were transported to Loudon County Jail without incident. All the above did occur in Loudon County, TN. Mary Arden is being charged with Man., Sale, Delivery of Schedule 2, Unlawful Drug Paraphernalia, and Maintaining a Dwelling for drug purposes. All other subjects are being charged with Man., Sale, Delivery of Schedule 2 and unlawful drug paraphernalia.

Legion Gives Donation to Food City Division

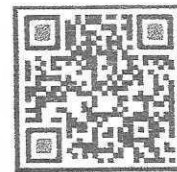

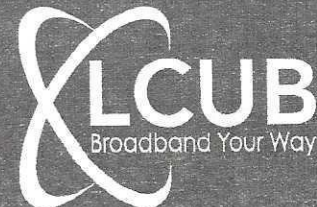

Timothy Lay, 50, Dixie Lee Drive Lenoir City, was charged with, Domestic Assault, and Public Intoxication.

Deputy Reagan LCSO, responded to a suspicious person on Hwy 70 near Stonebrook Ln. The deputy came into contact with a male at Hwy 70 near Kevin Ln. The deputy observed the male was shirtless, shoeless, blood covered, and had a towel around his forearm with a belt wrapped around his bicep. The deputy immediately began rendering aid by applying multiple gauze pads and wrapping the wound with pressure gauze. Just before the deputy could apply the gauze, the wound sprayed blood onto Deputy Brewer. The deputy identified the male as Timothy Lay (Arrestee). Lay stated that he cut his arm on a piece of glass while knocking on

his front door at Dixie Lee Cir. He was hesitant to explain all details of what happened. While speaking with Lay, The deputy could smell the odor of alcoholic beverage emitting from his person, as well as observed that he had slurred speech, and was unsteady on his feet. Cpl. Sartin responded out to Dixie Lee Cir to investigate further. Lay was transported to Tennova Healthcare, and Reagan responded out with Cpl. Sartin. Cpl. Sartin made contact with the Victim, and she stated that Lay and her had gotten into an argument which led to Lay walking out the front door. The victim said she and Timothy had been dating and living together. She then stated that she locked the door due to being afraid of Lay. The victim said that he then used a propane tank and a leaf blower to hit the door but was unsuccessful at getting the door open. Then he

went to the garage door and used a large metal bar to try and open the door inside of the garage. The victim stated that he then went back to the main door and punched through the glass and cut his arm. She stated that she exited the house and tried calling his parents. While calling, she stated that he threatened to kill her if she was calling emergency services, and he then grabbed her phone out of her hand and left. The vic-

tim stated that Lay is intoxicated and has medical issues that cause him to be aggressive. From the deputy investigation, he was able to determine Mr. Lay as the primary aggressor. This did happen in Loudon County, TN

While clearing from Dixie Lee Cir, Tennova Healthcare called and stated that Lay was available to be transported to the Loudon County

Jail. Upon arrival, the deputy spoke with Lay, and he became very aggressive. Lay began making threats to fight as soon as he is stitched up. The deputy explained to him that he would receive additional charges if he did what he described. He also stated that he hopes that the deputy is part of a statistic of officers that are shot and killed early in his career. Lay asked if the deputy had his weapon and then stated that the dep-

uty would have to shoot him to get him in handcuffs and take him to jail. At that time, the deputy called dispatch and asked them to advise Knox County to send a unit to assist with taking Lay into custody. Knox County units

arrived at Tennova, and Lay continued to make threats and be loud to the point of disturbing other patients. The deputy then placed Lay into custody without using force and transported him to the Loudon County Jail.

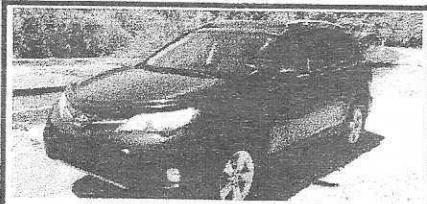

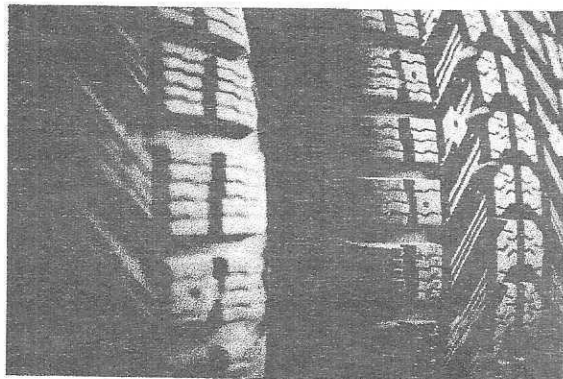

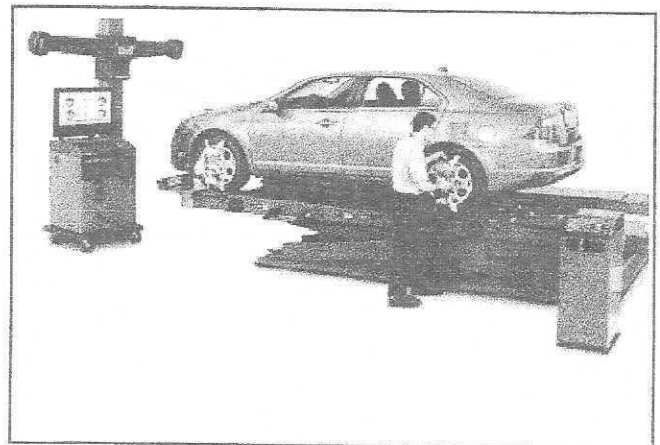
