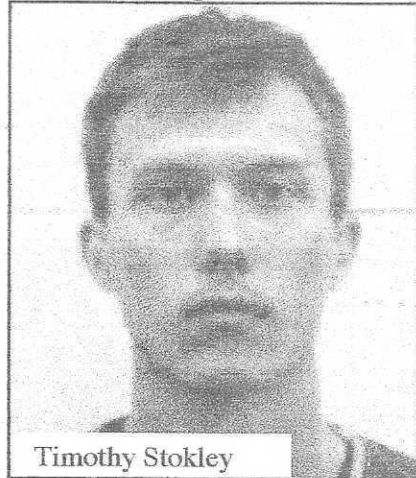

## Former Alamo City School District Official Pleads Guilty After Comptroller Investigation

An investigation by the Tennessee Comptroller's Office has resulted in a guilty plea by Ashley Haworth, a former federal programs and technology director for the Alamo City School District in Crockett County.

Investigators determined that Haworth made five unauthorized personal purchases totaling \$1,974.55 using a

school district American Express credit card between April 2022 and May 2023.

Haworth was able to conceal her activity because she was the sole school district employee responsible for reviewing the monthly credit card statements. She also changed the login password to the American Express online account which prevented access by other school district officials.

It should be noted that Haworth repaid the school district \$5,902.73, which includes repayment of unauthorized personal purchases, accrued interest, and associated late fees charged to the district. The amount was repaid based on calculations by school district officials.

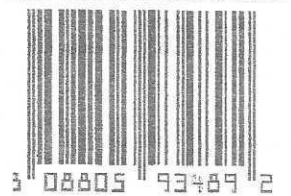

or pipe did not belong to them. Jose and Timothy were both placed under arrest for the meth and smoking pipe and placed in the back of his patrol unit. Timothy asked if he could talk to a Officer and Timothy was read his rights before talking. Timothy then tried to state that the pipe and meth belonged to him and not Jose. Jose and Timothy were transported to the Loudon County Jail. The said actions above occurred in Loudon County TN.

**Former White House Heritage PTO Treasurer Took Money from Father-Daughter Dances**

An investigation by the Tennessee Comptroller's Office has determined the former treasurer of the White House Heritage Elementary

School Parent Teacher Organization misappropriated at least \$8,000 from two father-daughter dance events.

The investigation began after Robertson County Schools officials reported financial discrepancies to the Comptroller's Office.

The PTO collected funds for entry fee donations, concessions sales, silent auction proceeds, and photography fees during both the May 2022 and May 2023 dance events. At the conclusion of both dances, the former treasurer took custody of the money and was expected to deposit it into the PTO bank account; however, no deposits were made.

In May 2024, the former PTO treasurer admitted to investigators that she had custody of at least \$4,000 after each dance, \$8,000 in total. She said she used a portion of the money to pay various personal expenses and retained the remainder in a bank bag. Furthermore, she told investi-

gators that in July 2023, when questions were raised about the missing funds, she panicked and threw away the bank bag containing the money in a dumpster.

On July 11, 2024, the PTO received an \$8,000 check for deposit on behalf of the former treasurer.

Investigators also identified collection shortages of at least \$1,265.87 related to various other events and fundraisers sponsored by the PTO. No records exist to reconcile these discrepancies, and neither the former PTO treasurer nor oth-

er PTO officials could explain them.

The results of the investigation have been communicated with the Office of the District Attorney General of the 19th Judicial District.

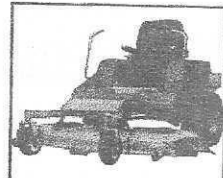
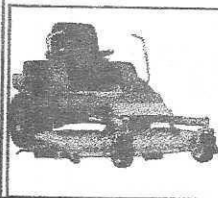
"Our investigation revealed a number of deficiencies related to oversight and accountability within the PTO," said Comptroller Jason Mumpower. "It is also a mistake to give one person the full responsibility for receipting and retaining collections, making deposits, record keeping, and bank reconciliations."

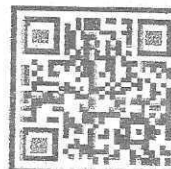

Alyssa Tuttle, 33, Mason Lane Loudon, was charged with DUI.

Deputy Parks LCSO, was dispatched to the area of Interstate 75 Northbound at the 82.4 mile marker for an MVA. On scene, the deputy made contact with one of the drivers involved, Ms. Alyssa Tuttle, and began gathering information about the accident. Ms. Tuttle told the deputy she did not need medical attention and she was trying to get in the turn lane on 321


where she was traveling and then the box truck collided with her van. None of this information was correct, and Ms. Tuttle had an odor of an alcoholic beverage emitting from her person. The deputy asked Ms. Tuttle if she would consent to performing Standardized Field Sobriety Tests, and she agreed to do so. While standing beside his patrol car, Ms. Tuttle fell down in the grass and the deputy had to help her back to her feet. Ms. Tuttle showed a lack of smooth pursuit, and a distinct and sustained nys-

tagmus at maximum deviation and onset nystagmus prior to 45 degrees. During the walk and turn, Ms. Tuttle could not maintain starting position and started too soon during the instructional phase. During the test, she took an improper number of steps, stepped off line, missed heel to toe, used arms for balance, made an improper turn, and stopped while walking. During the one leg stand Ms. Tuttle put her foot down, used arms for balance, and swayed. Due to all factors, I determined Ms. Tuttle to be under the influ-


ence of an intoxicant while operating a motor vehicle on a public roadway. I placed Ms. Tuttle under arrest and read her implied consent, and she consented to a blood draw. Ms. Tuttle was transported to Fort Loudoun Medical Center where a sample of her blood was obtained. While on scene at the hospital, Ms. Tuttle requested medical attention due to concerns she may have been injured during the wreck. Ms. Tuttle was left in the custody of medical staff. All of the above occurred in Loudon County, Tennessee.



**Sex Offender**

Steve Nomic, 57, Highway 72 Loudon, was charged with, Violation of Community Corrections, and Violation of Sex Offender Registry Address.

The Loudon police department was dispatched Highway 72 N in an attempt to locate a subject by the name of Steve Nomic. Central Dispatch advised he had active warrants for his arrest. Upon arrival, this officer made contact with the individual. After checking with dispatch, they advised he had two active warrants out of Loudon County for 39-13-526, Violation of Community supervision for life conditions, and 40-39-203, Violation of sex offender registration. Warrants issued on 08/30/2024 actions did occur in the City of Loudon.

**Investigation**

Investigation, on August 27, 2024, Ashley Haworth entered a guilty plea by way of criminal information to the Class A misdemeanor offense of attempted fraudulent use of a credit card over \$1,000 in the Crockett County Circuit Court. Haworth was granted judicial diversion and placed on supervised probation.

“School district officials should ensure they are providing adequate oversight over credit cards transactions,” said Comptroller Mumpower. “Designing internal controls which include reviewing credit card statements is a good step in preventing misappropriation.”
