to speak with the victim and her two children who were witnesses. The victim stated she allowed Johnson to come to the residence on 12-24-24 but did not allow him to come inside the home. At approximately 18:00 the victim stated Johnson kicked the front door in after Johnson requested to come in the house and gather belongings. Deputy Slattery did observe the door and door frame to be damaged estimated at \$1,000 under \$2,500. Once he entered the residence he began grabbing clothes from the laundry room and went outside to sleep in his truck. On this date, the victim allowed Johnson in the residence to

watch their young daughter open presents. During this time the two got into a verbal altercation. Johnson grabbed the victim phone, walked out, and left the residence. A short time later, Johnson returned and that's when the victim noticed her phone was missing. She walked outside to look for her phone in his vehicle at which point Johnson grabbed her by her hair and threw her to the ground. On this date, during the altercation, Johnson also threw a pipe at the victim car causing damage. Based on the physical evidence at the residence and victim and witness statements, Johnson was placed in custody.

Christopher Vavao, 45, Old Columbia Trail Knoxville, was charged with, DUI, and Poss. of Handgun while Under the Influence.

Ryne Miller Deputy LCSO, received a 911 call for a reckless driver in a Silver Dodge Ram travelling southbound on 175 near the 81 exit. The deputy located a vehicle matching that description on Route 321, getting ready to turn onto the entrance ramp to I75S. While behind the vehicle, the vehicle was unable to maintain lane, crossed the fog line, slammed on his brakes, and was unable to successfully navigate the merge lane onto the inter-

A traffic stop was initiated on the vehicle on I75S, mile marker 80.8. While approaching the vehicle, the vehicle began to roll forward and then stop once commands were given.

The driver, later identified as Christopher Vavao, was slow to comply with commands, taking several seconds to roll down the vehicle window. Once the vehicle window was rolled down, Vavao was observed

to have slurred speech, bloodshot eyes, an odor of alcoholic beverage about his person, and unable to form intelligible sentences. Vavao admitted to deputies he had been drinking and smoking weed. Vavao was asked to exit the vehicle and in doing so, was unsteady on his feet, unable to keep his balance, and attempted to walk to the front of his vehicle when advised to walk back toward the cruisers. Vavao was so unsteady on his feet, that deputies had to assist him in walking.

Deputies attempted to conduct Standardized Field Sobriety Tests (SFST's) but due to the unsafe nature, they were not performed. At this time he was placed under arrest for DUI. An inventory search of his vehicle yielded a loaded Springfield Hellcat .9mm in the center console. Vavao was read implied consent but refused to provide a sample of blood.

He was transported to Loudon County Jail and charged with DUI and unlawful possession of a handgun.





Erica Helton, 20, Upper Street Loudon, was charged with, Mfg/Del/Sale or Poss. of Meth, Simple Possession, nd Poss. of Drug Para.

Officer R. Miller, with the Lenoir City Police Department, was conducting traffic enforcement in the area of the 400 block of West Broadway in Lenoir City, TN. During his enforcement duties the officer observed a black in color Mazda sedan traveling east on Broadway. While observing the vehicle the officer visually observed the front seat passenger later identified as Erica Helton (defendant) not wearing her seatbelt while the vehicle was in motion on a public roadway. The officer then ini-

tiated a traffic stop on the Mazda sedan in the area of 2nd Avenue at A Street. Upon the traffic stop the driver was identified and the rear seat passenger was identified. During the traffic stop while filling out a citation and waiting for central dispatch to return with information pertaining to the traffic stop, the officer was granted verbal consent to conduct a search of the vehicle from the driver. During the consented search of the vehicle, the officer noticed a strong odor of marijuana emitting from the inside of the vehicle. Once the odor of marijuana was noticed. Officer T. Eldridge, who was assisting on the traffic stop was handed a small bag containing a green leafy substance believed


to be marijuana from the front seat passenger, ER-ICA (approximately 1.79 grams). During the subsequent search of the vehicle, the officer located a pink in color bag that was sitting in the passenger's side front floor board inside of the vehicle where ERICA was sitting. Located inside of the pink bag was a glass pipe which was black/

charred on the bowl of the pipe. The glass pipe that was located is commonly used to smoke methamphetamine with. Also recovered from the pink bag was a bag containing a crystal-like substance believed to be methamphetamine (less than half a gram) along with another bag which contained a crystal-like residue.

provides clinical laboratory services through LCTN at UTMC's outpatient laboratory. According to filed documents, between March 2012 and November 2023, UHS and LCTN caused the delay of the submission of physician orders for Caris testing, by either holding orders for submission or cancelling and resubmitting orders, until 14 days after a Medicare beneficiary's discharge from the hospital to circumvent Medicare's Date of Service Rule, which allowed the submission of claims to Medicare. The United States contends that, in doing so, UHS and LCTN violated the Date of Service Rule and knowingly caused the submission of false claims for reimbursement to Medicare. UHS and LabCorp cooperated with the United States' investigation and resolution thereof. Caris, for its part, previously agreed to pay \$2.8M to resolve allegations in the East-

its related conduct on a nationwide scale.

This settlement resolves, in part, a lawsuit filed under the qui tam, or whistleblower, provisions of the False Claims Act, which permits private parties to sue on behalf of the government for false claims and receive a share of any recovery. The qui tam case is captioned Ûnited States ex rel. Kim Vo v. Caris Life Sciences, Inc. et al., No. 3:20-CV-509 (E.D. Tenn.). Relator Kim Vo received \$73,846.76 of the proceeds from the settlement. UHS was not a party to the qui tam case but participated in the settlement.

The investigation and resolution of this matter illustrates the government's emphasis on combating health care fraud. One of the most powerful tools in this effort is the False Claims Act. Assistant U.S. Attorneys Alexa Ortiz Hadley and Jeremy S. Dykes represented the United States, with assistance from the Department of Health and Human Services' Office of Inspector General and Trial Attorney Robert C. K. Boyd of the Department of Justice's Civil Division, Fraud Section.

The claims resolved by this settlement are allegations only, and there has been no determination of liability.
