#### Hang Up

Daniel Nicolo, 37, South East Cove Cleveland, was charged with, Aggravated Assault.

Deputy Billy Freeman LCSO, was dispatched to Little Valley Road in Loudon for a 911 hang-up call. Upon arrival, the deputy heard loud music coming from inside the house, followed by the sound of a male yelling and a female crying. After Sergeant Brandon Pesterfield and Deputy Brooke Slattery arrived on the scene, they attempted to knock on the door and announce, "Sheriff's Office." After several attempts to gain entry, Sgt. Pesterfield checked the exterior of the

house and observed a male through the back door. This male, identified as Mr. Daniel Nicolo (offender/arreste), then opened the back door, allowing Sgt. Pesterfield to make contact. The deputy proceeded to the back of the house, where Deputy Slattery had already detained Mr. Nicolo on the back porch. Upon entering the house with Sgt. Pesterfield, they located the female, identified as the (victim), lying in bed. While speaking with her, the deputy observed redness on her face and shoulders, along with marks on her neck that were consistent with strangulation by hand, based on his training and experience. The victim stated that she had been in

bed the entire time and that Mr. Nicolo was in the kitchen washing dishes. The deputy then spoke with Mr. Nicolo. who claimed they had been out drinking and that the victim had been in bed since they returned home. He also said he decided to wash the dishes and nothing more. The deputy observed that Mr. Nicolo had a swollen bottom lip and a strong odor of alcohol on his person. When the deputy asked how they knew each other, Mr. Nicolo stated they had been in a relationship for over a year. Upon further investigation, it was determined that Mr. Nicolo was the primary aggressor after the victim made a spontaneous statement that she

was defending herself when he sustained the injury to his bottom lip. Mr. Nicolo was taken into custody. Mr. Nicolo was read his Miranda rights and transported to the Loudon County Jail. While gathering evidence, the victim did have bruises on her shoulders and both arms, swelling on the left side of her face, scratch marks on her chest, a busted upper and lower lip on the left side of her face, and a cut on the back of her head (photographed in the report). Deputy Slattery then transported the victim to Fort Loudon Medical Center for medical clearance. This did occur without further incident in Loudon County, TN.

Investigator Chance Gray LCSO, was advised of a small black locked container that Cpl. Wallen had located concealed in Katherine Shelton pants after locating multiple items of Paraphernalia in the vehicle and her belongings. Shelton advised the deputy that she did not have a key nor did she know the contents of the container. Due to multiple items of drug para. throughout the vehicle, and obvious attempt to conceal the container from deputies. According to the reports, Officers attempted a traffic stop on a burglary suspect, who then fled the scene, starting a pursuit. The chase led officers through Loudon County and into the City of Loudon. Due to the suspect's dangerous and reckless driving, Loudon County deputies and Loudon City officers deployed spike strips, bringing the pursuit to a safe end and the suspect into custody.

Shortly after, detectives and officers identified a second wanted felon in another vehicle. When officers attempted to stop the vehicle, the driver fled, leading authorities on a pursuit down I-75 South, ending in Meigs County, where the suspect was apprehended after his vehicle was disabled.

The first suspect was driving a gray short bus, which had been stolen earlier that morning in Hamblen County. The bus driver also had felony warrants out of Hamilton County. The second suspect, a convicted felon on active felony probation, was wanted for multiple felony warrants out of Knox and McMinn counties. Both suspects will be facing numerous felony charges from our agency.

Thank you to Loudon County Sheriff's TN. Loudon Police Department, Tennessee Highway Patrol, Meigs County Sheriff's Office, The McMinn County Sheriff's Office, and Monroe County Emergency Services - 911 for their help in ending these pursuits safely.


All suspects are presumed innocent until proven guilty in a court of law.

### Meth Charge

Samantha Russell, 53. Kirkland Drive Madisonville, was charged with, Mfg/ Del/Sale or Poss. of Meth.

Deputy B. Slattery LCSO, was dispatched to Sugarlimb Rd., just before the northbound exit ramp from I-75, in reference to a suspicious person lying in a ditch. Upon arrival, the deputy made contact with Deputies B. McCall and B. Freeman, who were already in contact with the suspect, Samantha Russell. The deputy approached Ms. Russell, who stated that she was on her way home and had run out of gas. Before escorting her to a nearby gas station, the deputy asked for her consent to search her person for any illegal weapons or contraband. After obtaining verbal consent, the deputy conducted

a pat-down search and located a small white napkin in her front left jean pocket. Upon removing the napkin and unrolling it, the deputy discovered a broken clear pipe and a small clear baggie containing a white, crystal-like substance, which the deputy suspected to be methamphetamine based on her training and experience. Ms. Russell denied ownership of the items, stating, "That is not mine. I meant to throw it out." the deputy then transported Ms. Russell to the Loudon County Jail, where Narcotics Detective C. Green used the TruNarc device to test the substance. The test came back positive for methamphetamine, with an approximate weight of 1.2 grams. This incident occurred without further issue in Loudon County, Tennessee

maintained multiple addresses across Knoxville to stash his narcotics, firearms, and cash to facilitate his narcotics distribution. In addition, the evidence showed that, in furtherance of his drug trafficking, at approximately 2:45 p.m. on November 21, 2019, Cornelius, along with two others, drove by the Stop-n-Go on Brooks Avenue and Cornelius and fired fifteen rounds of 7.62mm Mercedes-Benz. The driver sustained two non-life-threatening gunshot wounds. The jury also convicted Cornelius of conspiracy to commit money laundering. According to court documents, twenty-two other charged members of the conspiracy previously pleaded guilty.

In determining the sentence, Judge Varlan took into account several aggravating factors, including Cor-

nelius's role as a leader and organizer of the crimes, his credible threats of violence made against other people in connection with his crimes, and his use of guns and violence in connection with his crimes.






