

Officer Garren, along with Officer Tatham LCPD, were dispatched to a call for a suspicious vehicle at Jim Hartsook Drive, in reference to a Gold BMW X5, bearing Tennessee Registration 412BKBL, that had been sitting outside of the apartment for fifteen to twenty minutes, per the complainant. The complainant advised the vehicle was occupied two times and was still running with the lights on. The vehicle regis-

tration was ran through central dispatch and the address on file did not match the Jim Hartsook Drive address of the call. Once on scene, officers made contact with the passenger of the vehicle who identified herself as a female who explained that they were just driving around to leave the house for a little while. They had been running errands to get her car sold and a few other things. Mark attempted to provide Officers with a false identity. The name given to Officers was that of his brother. Once Marks name was confirmed, Officer Tatham and Garren had central dispatch check for local warrants. The Loudon

County Jail confirmed that Mark Davis had two warrants for failure to appear through the Loudon County Criminal Court. Mark was placed into custody for the two warrants on failure to appear and obstruction with providing a false identity. Mark was transported to Loudon County Jail without further incident. The above did occur in Lenoir City, Loudon County, TN.

John Allen, 23, Carey Road Speedwell, was charged with, DUI, Open Container, Speeding, and Violation of Implied

Deputy Allen LCSO, witnessed a red Mustang travelling west on Highway 72 at 95 MPH in a marked 50 MPH zone verified with radar. The deputy turned around on the vehicle and activated his emergency equipment. The car stopped on Highway 72 near Malone Road. As the deputy exited his patrol car he noted the driver moving a lot in their seat. The deputy gave verbal commands from his vehicle telling the driver to turn off the vehicle and hold their hands out the window. The driver complied. Upon his arrival at the driver's side window, the deputy found John M. Allen in the driver's seat. Mr. Allen has a strong odor of alcoholic beverages coming from his breath, bloodshot watery eyes, and slurred speech. The deputy asked Mr. Allen to exit the vehicle to perform standardized field sobriety testing. Mr. Allen agreed, but would not follow the instructions given, refusing to follow visual stimuli with his eyes. Mr. Allen then agreed to perform the walk-and-turn test but again refused to follow instructions. Mr. Allen attempted to begin before the end of

the instruction phase multiple times. Given the totality of the circumstances, the deputy was able to determine Mr. Allen was under the influence of an intoxicating substance. Mr. Allen was placed under arrest. Mr. Allen did agree to a blood draw and was transported to Fort Loudoun Medical Center. Upon staff there attempting a blood draw Mr. Allen would not sit still or argued with the staff and law enforcement about how the blood draw was going to be done. The deputy was able to determine that Mr. Allen was verbally consenting, but was impeding and refusing a blood draw with his actions. Mr. Allen was transported to the Loudon County Jail. Upon arrival at the jail while the deputy was checking his back seat the deputy found that Mr. Allen had vomited in the back seat. The vomit had a strong smell of alcoholic beverages. While Deputy Davis was performing an inventory of the vehicle for it to be towed he found an open nearly empty bottle of Pinnacle Whipped vodka on the floor behind the driver's seat. This did occur in Loudon County TN.






