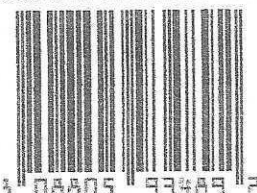

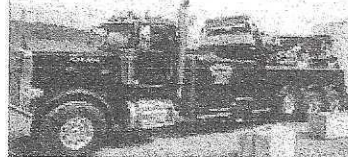

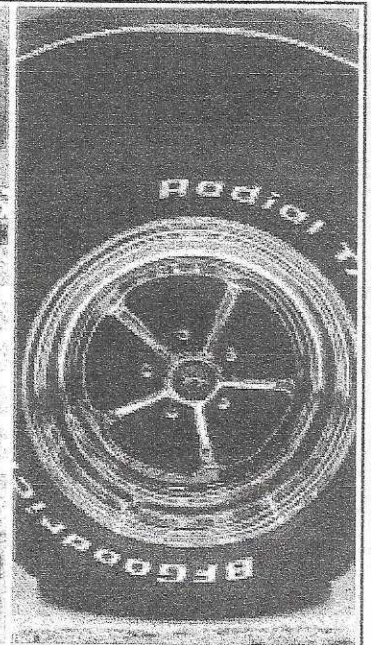

Ali Aadel, 41, Water Mill Drive NC, was charged with DUI, and Violation of Implied Consent.

Deputy Watson LCSO, responded to Watt Road (TA Truckstop) in reference to a possible intoxicated person. The complainant advised a male was inside the store acting intoxicated but had now gotten into a semi-truck and was passed out. Upon arrival, the deputy observed a white semi-truck in the parking lot. While the deputy was approaching the vehicle, a bystander stated the male was passed out. The officer observed a male passed out with his head back and mouth wide open in the driver's seat and the truck was running. 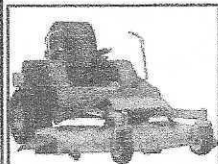

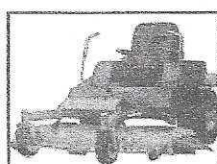

Officers with the Lenoir City Police Department, were initially dispatched to the address of Delaney, located in Lenoir City, TN in regards to a physical domestic where the complainant stated that a male subject was physically hitting a female and would not let her leave. Upon officers' arrival it was determined through the investigation that the domestic did not take place at Delaney Way and that the correct address was Delaney Way. Executive Clemency Hearings to be held April 22-23 in Nashville

Hearings to be conducted at 500 James Robertson Pkwy., Davy Crockett Tower

The Tennessee Board of Parole will conduct executive clemency hearings on Tuesday, April 22 and Wednesday, April 23 at its downtown Nashville central office, located at 500 James Robertson Parkway in the Davy Crockett Tower.

The April 22 hearings will start at 9:30 a.m. Central Time with a lone pardon hearing at the first floor conference room (1-A). Hearings will resume later at 12:30 p.m. in the Chairman Richard Montgomery Board Room, located on the fourth floor.

The April 23 hearings will begin at 9 a.m. and take place

in the Chairman Richard Montgomery Board Room.

The Board is responsible for reviewing all clemency requests (pardons, commutations, and exonerations) and submits non-binding recommendations to the Governor for his consideration. Only the Governor can exercise Executive Clemency power.

The hearings are open to the public.

The Board of Parole is an independent seven-member board whose members are appointed by the Governor. The Board makes decisions about which eligible offenders will be granted parole and placed on community supervision for the remainder of their sentences. The Board also can revoke parole of those offenders who do not abide by the conditions of their supervision.
