
101-54110-170— The Sheriff is requesting two (2) additional School Resources Officers to the 2019-2020 budget year. The purpose of the additional SRO's are to assist in the safety and security of the two county high schools (Greenback and Loudon). The additional SRO Deputies will assist in covering all schools in the event an SRO Deputy is off on vacation or sick.

101-54110-106 — The Sheriff is requesting an additional one (1) General Sessions Court Officer. Due to the increase in case volume and an additional Sessions Judge, there are many times we have multiple courts operating at the same time. We also run into this problem at the Criminal Courthouse. In times court is not in session we plan to use the additional officer for security at the Courthouse Annex.

101-54110-106— The Sheriff is requesting three (3) additional Patrol Deputies. This request is based primarily on overall safety for the deputies as well as better serving our citizens.

In the spread sheets provided you will also discover an increase in wages for Post Certified personnel in the Sheriff's Budget and all Detention Center Staff. This is an attempt to contend with neighboring agencies hiring our trained and experienced personnel. In the last approximate two years we have lost eleven (11) Post Certified Deputies and several Corrections Guards to other employers. In the fall of last year we had a third of our total corrections staff with less than 60 days experience. Seven of the certified deputies went to Lenoir City Police Department. Stating better salary, benefits and retirement, primarily the reason for leaving the Sheriff's Office. We request strong consideration to assist in retention of our valuable employees.

New Jail Employees— As you are all aware of the expected completion of the jail addition in early 2020. Therefore we are requesting funding to begin the staffing process. Mr. Jim Hart with CTAS has completed his staffing analysis of our facility, his recommendation is to add and additional thirty-six (36) correctional staff. Also included in your packet is a break down of the new job assignments and responsibilities.

101-54110-471 (Software) The Sheriff is requesting funding to upgrade our Records Management System for the Sheriff's Office and Detention Facility. The upgrade will protect all records from server failure. The web based system will improve efficiency and will allow deputies to access our data base system from the field. This will keep deputies in their assigned zones and keep them from traveling to the Justice Center to file reports. This gives better response times and should reduce overtime. The cost is \$69,000.
